COVID-19 VACCINE PASSPORT IN EFFECT

To ensure your safety and further protect you when visiting our event, we ask for your cooperation.

Vaccination Requirements:

Anyone attending the OFPA Spring Technical Meeting and Clive Kingsbury Video Competition will need to be fully vaccinated (2 doses plus 14 days).

Contact Tracing and Entry Requirements:

Upon entry to the Event Centre, guests will be required to provide the following:

- Ontario COVID-19 enhanced vaccine certificate (QR code proof of vaccination). This can be downloaded by clicking [here](#)
 - Tip: save this to your phone for quick access
- A piece of government issued photo ID showing full name

Guests will be provided with a link with a 24 hours prior to arrival with questions related to contact tracing and symptoms. This is to be filled out no earlier than 24 hours prior to entry.

Masking & Sanitation:

We ask that you keep your mask on at all times (unless eating or speaking on stage) and social distance (where possible).

Centennial College follows all Toronto Public Health Guidelines as it relates to social distancing and COVID -19.

The Event Centre is committed to enhanced disinfecting and cleaning and all staff are trained on hygiene measures and undergo daily screening.

The purpose of the Centennial College COVID-19 Pre-Screening assessment is to have community members report the existence of any potential COVID-19-related symptoms and exposure history. You are not expected or required to disclose medical conditions unrelated to COVID-19.

Question 5	Has a...	Doctor, healthcare provider, or public health unit told you that you should currently be isolating (staying at home)?	Yes	No

Results of Screening Questions:

Individuals who answer **NO to all questions from 1 through 4** have passed and **can** enter the College. Everyone is required to wear appropriate personal protective equipment and to self-monitor for symptoms. Individuals must complete the COVID-19 Pre-screening Assessment each day before they come to the campus, and are encouraged to complete it every day.

Individuals who answer **YES to any question from 1 through 4** have not passed and **cannot** enter the campus. Those who do not pass are asked to return home and self-isolate immediately. Employees should contact their manager/immediate supervisor, and will be told to contact a primary care provider, local public health unit or Telehealth to discuss their symptoms and/or exposure, and seek advice on testing.
